

## INTERNATIONAL COMPETITION APPLICATION FORM

SANCTIONING PROCESS
International Competition Application forms must be completed in full and submitted to IPC Shooting Office at <a href="mailto:ipcshooting@paralympic.org">ipcshooting@paralympic.org</a> <b>no later than 6 months</b> prior to the commencement of the competition.
Applications submitted outside the given timelines or are not completed in full will not be accepted.
IPC Shooting will announce its decision to approve the competition officially in writing.
If approved a <b>100€</b> fee must be submitted by the LOC to IPC account and the LOC will be invoiced by IPC Shooting.
All international competitions approved by IPC Shooting will appear in the IPC Shooting Calendar.

AREA	MINIMUM REQUIREMENTS
<b>Endorsement</b>	If the competition is organized by a different LOC and not by the NPC the application must be endorsed by the respective NPC. The respective field in this application must be filled out.
<b>Rules</b>	The competition will be held according to current ISSF and IPC Shooting Rules.
<b>Programme of Events</b>	The programme of events can be (the events in the parenthesis are optional): <ul style="list-style-type: none"> <li>• <b>Programme 1:</b> R1- R9, P1-P5, (Falling targets)</li> <li>• <b>Programme 2:</b> R1-R5, P1-P2, (P5), (Falling targets)</li> <li>• <b>Programme 3:</b> R6-R8, P3-P4</li> </ul>
<b>Finals</b>	Finals are required for all the events in all Programmes.
<b>Time Schedule</b>	The time schedule should be developed by the LOC taking into consideration the number of firing points, expected number of athletes per event, type of targets (e.g. paper or electronic). The schedule needs IPC Shooting prior approval.
<b>Number of days for International Classification and Equipment Control</b>	Two (2) days are required prior to the competition days.
<b>Equipment</b>	Set of measurement devices for SH1 and SH2 class equipment control. If those are not available it must be communicated to IPC Shooting
<b>Entries</b>	<p>The number of entries for the competition must be a minimum of three (3) by the final entries deadline. IPC SH reserves the right to cancel any events which are not viable and inform the LOC in a timely manner.</p> <p>The athlete's final entries must be sent to IPC Shooting office the day after the final entries deadline and not later than <b>4-6 weeks</b> prior the start of the competition. The athlete's SDMS ID number, international sport class and sport class status (if available) must be included in this list.</p>
<b>Technical Officials</b>	<p>The competition must be officiated by recognized ISSF and IPC Shooting referees.</p> <p><b>Chief Referee:</b> A Chief Referee outside the Host Country will be appointed by IPC Shooting. (For programmes: 1, 2, 3)</p> <p><b>International Referee:</b> An International Referee outside the Host Country will be appointed by IPC Shooting. (For programme: 1,2,3)</p> <p><b>National Referees:</b> will be selected by the LOC as per ISSF rules.</p>
<b>Classification panel</b>	The International classification panel will consist of two (2) International Classifiers and will be appointed by IPC Shooting. For protest opportunities 2 panels of two (2) International Classifiers each must be appointed as per the IPC Classification Code. Total number of classifiers 4.

<b>Results</b>	The LOC must submit the results from all events to IPC Shooting in the electronic version on the standardized template submitted by IPC Shooting <b>no later than 7 days</b> after the end of the competition.
	Results recognition will follow the IPC Processes for rankings and records lists.
